

HOLIDAY & SPECIAL EVENT PERIODS:

Holiday rates, cancellation and minimum-night stay policies apply on the following dates in 2012:

Memorial Day and Labor Day holidays require 3 nights.

January 1, 2; February 16, 17, 18, 19, 20; March 1, 2, 3, 4; **May 24, 25, 26, 27, 28;** June 28, 29, 30; July 1, 2, 3, 4; 23, 24, 25, 26, 27, 28, 29; **August 30, 31; September 1, 2, 3;** October 4, 5, 6, 7, 8, 18, 19, 20, 21, 25, 26, 27, 28; November 19, 20, 21, 22, 23, 24, 25; December 26, 27, 28, 29, 30, 31; (January 1, 2013).

CHECK-IN & CHECK-OUT:

Check-in time is 1 p.m. and Check-out is 12 noon. If sites are available, Early Check-in or Late Check-out may be available for an additional charge of one-half of the discounted Club rate.

MEETING SPACE:

Meeting space at 49er Village RV Resort may be reserved by Clubs and is assigned on the basis of the number of paid RV sites and availability. Meeting space is available between the hours of 8 a.m. and 10 p.m. Clubs are responsible for cleaning up meeting space and cooking facilities daily after usage. Clubs will be charged a \$500 cleaning fee if the meeting space and/or cooking facilities are not left clean.

COTTAGE RENTALS:

Cottage rentals require a minimum 2-night stay. Clubs receive a 10% *non-holiday/special event* discount on Cottage rentals of 2-4 nights; 15% for 5-6 nights and 18% for 7 or more nights. *Holiday/special event discount* is 10%. A 1-night deposit is required at the time the Cottage reservation is made. Cancellation policy is in the Cottage brochure.

PROSPECTORS CLUB:

Clubs become members of the 49er Village RV Resort's *Prospectors Club* with their second, non-holiday/special event visit in one calendar year (January-December). *Prospectors Club* benefits include:

- Additional 10% discount on non-holiday Club rates
- Waiver of the reservation deposit*

*All Club policies apply even though the deposit has been waived. If a *Prospectors Club* Wagonmaster cancels the entire club reservation with less than 60 days (non-holiday) or 90 days (holiday) prior to the scheduled check-in date, the Wagonmaster is responsible for paying the full deposit fee that was waived.

Enjoy Club benefits when you have a minimum of 10 paid sites for a minimum of 2 nights.

DEPOSIT:

The deposit is due within 30 days of the date the reservation is made. In the event that the arrival date is within 30 days of the date the reservation is made, the deposit needs to be paid with a credit card at the time of the reservation. In the event that sites are added, the deposit received needs to correspond with the number of sites reserved.

TAX:

49er Village RV Resort is required to collect the prevailing Transient Occupancy tax and California Tourism Assessment (currently 6.065%) on all site fees. These taxes are mandatory and are in addition to the amounts listed in this brochure.

PAYMENT:

A Club invoice, based on the number of reserved sites on the Club roster, will be prepared and provided to the Wagonmaster prior to arrival. Payment may be made with 1 club payment or by individual club members at check-in.

RATE DETERMINATION:

Both Standard and Premium sites are available for Club rates. A Club outing may contain any combination of Midweek, Weekend or Holiday nights as long as minimum-stay requirements are met.

NON-HOLIDAY CANCELLATION:

Entire Club: Written cancellation notice must be received at least 60 days before the Club's scheduled check-in date. If less than 60 days notice is given, the deposit will be forfeited and penalties incurred.

Individual Sites: Individual sites may be canceled by phone or email up to 7 days before the Club's scheduled check-in date, subject to 10-site minimum. Clubs will be charged 2 nights' fees for any sites canceled with less than 7 days in advance of the check-in date.

HOLIDAY & SPECIAL EVENT CANCELLATION:

Entire Club: Written cancellation notice must be received at least 90 days before the Club's scheduled check-in date. If less than 90 days notice is given, the deposit will be forfeited and penalties incurred.

Individual Sites: Individual sites may be canceled up to 14 days prior to the beginning of the holiday period, subject to 10-site minimum. Clubs will be charged the holiday/special event minimum-night stay (2 or 3 nights) for any sites not cancelled by the published deadline..

MINIMUM OCCUPANCY:

Clubs must have a minimum of 10 sites or 20 camper nights (# of sites times the # of nights) to receive the club rates and benefits. All club sites require a 2-night minimum stay.

MINIMUM-NIGHT STAY:

In order to qualify for Club rates, **all** RV sites in club must be occupied for a minimum of two (2) non-holiday nights or three (3) holiday nights for Memorial Weekend and Labor Day. Clubs are financially responsible for the minimum-night stay for any sites not cancelled by the cancellation deadlines, whether the sites are occupied or not.
